#### Job Description

This position will also provide marketing support to other CSAC Finance Corporation programs. This is a full-time position and requires frequent travel.

- Manages the CalTRUST client service operations, which deals directly with clients and is the first point of contact.
- Develops, tracks and reports key performance indicators.
- Coordinates and conducts CalTRUST education and outreach programs to participants in California.
- Assists in identifying new growth areas.
- Assists in coordination of CalTRUST monthly newsletter.
- Identifies proper decision makers in target agencies.
- Travels throughout California to meet with current and potential CalTRUST participants and county officials.
