RE: Assembly Bill 1250 (Jones-Sawyer) – Restrictions on Counties Ability to Contract Out Services - OPPOSE

Dear Senator McGuire:

I am writing on behalf of the Santa Barbara County Board of Supervisors to state our <u>opposition</u> to Assembly Bill (AB) 1250 introduced by Assemblymember Jones-Sawyer. The Board of Supervisor's adopted a 2017 Legislative Platform built upon legislative principles of efficient delivery of county services, fiscal stability and local control. Specifically, the legislative principles state, "Ensure local control over . . . delivery of services, including flexibility and customization in designing and implementing policies and services that are responsive to the community's preferences." **AB 1250 certainly doesn't ensure local control and warrants opposition**.

AB 1250 appears to:

- Negatively impact the County of Santa Barbara's ability to exercise local control over the efficient delivery of county services by subjecting a large number of new and existing contracts for services to significant data collection, financial analysis and audits. AB 1250 does contain very limited exemptions, but other services for laundry, landscaping, ambulance transport, legal, information technology, revenue collection, and prehospital EMS care services would be subject to the significant audit, financial analysis and data collection requirements, and
- Create a new unfunded state mandate to conduct specific and extensive data collection, financial analysis
 and audits on all new and existing contracts. The cost of reviewing and validating the accuracy of the
 data collection, financial analysis and audits will be a significant additional burden on counties.
 Without validation by county staff, the conclusions reached through these processes will have limited
 value. The County of Santa Barbara Legislative Principles specifically opposes the creation of new
 unfunded mandates.
