Criminal element



## **AUMA Impacts**

- Industrial hemp added to the mix
  - CDFA to have a program by January 1, 2017
- No size limit licenses
  - Type 5, 5A and 5B
    - Available after 1/1/2023
    - Allows vertical integration
- Unlimited type 3 licenses
- Local jurisdictions can no longer prohibit indoor cultivation of 6 plants or less for personal use (Yield potential of 18 to 24 pounds)



#### Legal cover for black-market operations

Limits Exemption: Patient's medical condition necessitates cultivation of up to 99 plants (combination of mature and/or immature) and 11 lbs of usable cannabis based on processing and consumption.







- 1 to 2 pounds per plant (3 to 4 crops per year)
- \$1,500.00 per pound
- \$62.53 per square foot
- \$2.7 million per acre

- Case 1 Non-compliant ½ Acre THC grow
  - Cost
    - 16 employees x 20 hours x \$200/hr = \$64,000
  - Proposed Revenue
    - 23,000 square feet x \$1.75/ sq. ft. = \$40,250
    - Initial regulatory fee = \$7,500
      - Total revenue \$47,750
  - Fully licensed facility cost
    - 12 employees x 20 hours x \$200/hr = \$48,000

- Case 2 Non-compliant 300 square feet THC grow
  - Cost
    - 10 employees x 15 hours x \$200/hr = \$30,000
  - Proposed Revenue
    - 300 square feet x \$1.75/ sq. ft. = \$ 525
    - Initial regulatory fee =  $\frac{$7,500}{}$ 
      - Total revenue \$ 8,025
  - Fully licensed facility cost
    - 4 employees x 15 hours x \$200/hr = \$12,000

- Case 3 Non-compliant 200 square feet personal grow
  - Cost
    - 3 employees x 10 hours x \$200/hr = \$6,000
  - Proposed Revenue
    - Registration fee = \$ 100

- Case 4 Voluntarily discontinued complaint grow
  - Cost
    - 4 employees x 5 hours x \$200/hr = \$4,000
  - Revenue
    - = \$ 0
